The Joint Electricity Regulatory Commission for Union Territories of J&K and Ladakh (JERC-JKL) intends to engage INDIVIDUAL CONSULTANT for assisting the Commission in discharging its functions under Electricity Act 2003 and Regulations made there under. The engagement will be on short-term contract basis from amongst persons having experience and working knowledge of dealing with Generation, Transmission, and distribution of electricity. Those candidates having prior experience of working in Electricity Regulatory Commissions shall be given preference.

The consultant will be engaged as per following terms & conditions: -

- The Consolidated monthly remuneration shall be **Rs. 74000/-**.
- The candidate must have at least **05 years** working experience in Regulatory affairs of power sectors.
- The candidate must be **B.E/ B.Tech. Electrical**.
- Candidates within age limits of **62 years** as on 1st January 2023 shall be eligible to apply. No extension shall be given to consultant after attaining the age of **65 years**.
- Shall be appointed initially for a period of two years.
- Extension may be given for one year subject to the condition that the maximum period of continuous appointment of consultant in no case shall exceed four years, subject to the satisfactory performance of consultant.

Appointment of consultant shall be purely on contract basis and such appointment shall not confer any right whatsoever to claim for regular appointment or continued contractual appointment in JERC. The Commission reserves the right to terminate the contract at any stage. **Scope of work** and other detailed **terms and conditions** are contained in **Annexure I**.

Annexure-I

Term of Reference (ToR) for engagement of Consultant for assistance to the Commission

1. Scope of Work:

- a. The consultant shall assist the commission in discharging its functions under the Electricity Act, 2003.
- b. The Consultant shall advise the Commission on all technical/Regulatory Matters for efficient discharge of its functions under the Electricity Act,2003
- c. The consultant shall assist the commission in preparing reply to MOP/CERC/FOR/FOIR/APTEL etc. of various communications/directives/Guidelines received from them
- d. The Consultant shall prepare annual report for Commission.
- e. The Consultant shall assist the Commission in preparation/updating/modification of Regulations.
- f. The Consultant shall assist the Commission in updating the website of the commission and other IT related matters.
- g. The consultant shall study and examine all aspects regarding the ARR and retail supply tariff determined for Distribution licensees on annual basis viz-a-viz the multi-year period. The experience of other State Regulatory Commissions in determination of ARR and retail supply tariff on annual basis/ multiyear period shall be obtained and same shall be placed before the Commission for consideration.
- h. For fixing the norms, the consultant shall analyze the financial and operational data obtained from the distribution licensees/generating companies/ transmission Company, as the case may be. Review of the existing operational norms/performance parameters on the basis of aforesaid analysis and formulation of revised/new financial and operational norms, wherever necessary.
- i. Any other matter referred to by the Commission with regard to distribution/ transmission/ Generation/ Trading utilities.
- j. Any other matter referred to by the Commission with regard to hydro/ renewable generation utilities.
- k. Review the provisions of existing Regulations and identify the areas where amendments are required in light of constraints if any noticed, in implementation of Regulations. Revisit the formats specified in order to avoid multiplicity of information & monitoring of regulatory information tools.
- l. Preparation of formats with the respective Regulation for obtaining the information and actual data/projections of data for determination of annual as well as multiyear tariff.

2. General Terms & Conditions for Consultants:

- a. Engagement of consultant will be initially for two years.
- b. The Commission may hold review meetings, as and when needed, with the consultant.
- c. The consultant shall not utilize or publish or disclose or part with any statistics, data/proceeding or information collected during discharge of his function, without the express written consent of the Commission. The consultant shall be duty bound to hand over the entire record of assignment to the Commission before the expiry of the contract.
- d. The assignment may be terminated by the commission at any time.
- e. The selected consultant shall be initially empanelled for a period of two year, subject to curtailment or extension at the discretion of the Commission.
- f. Selected candidate shall be willing to work for commission at Jammu/Srinagar.
